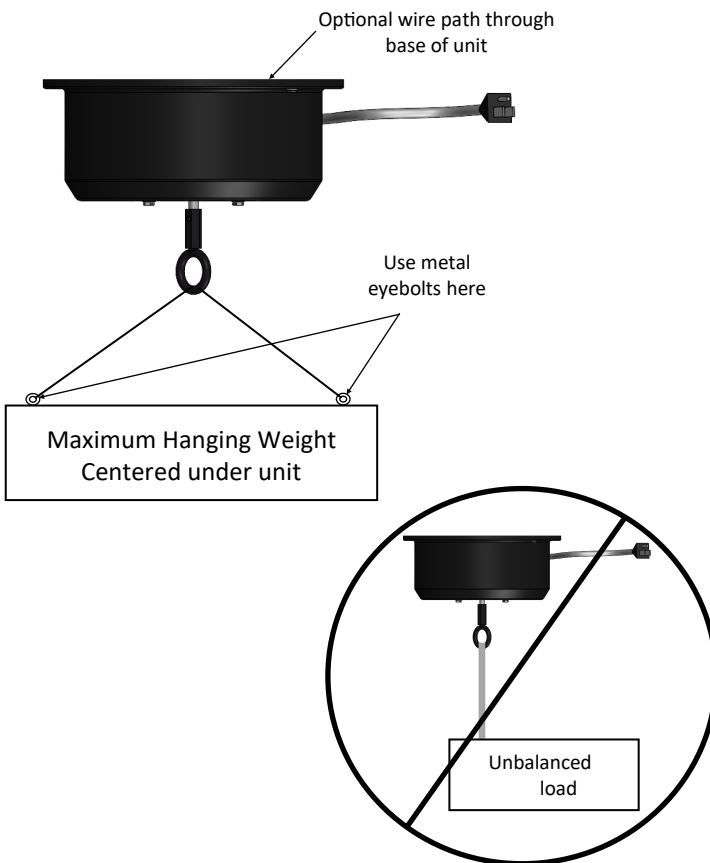

#### For ALL installations:

- Display or sign load MUST be balanced and centered under unit.
- Do NOT exceed rated capacity of unit.

#### Display or Sign hanging from Rotator:



Model:	Max. Hanging Weight:
CT105	15 lb
CT110	40 lb
CT120	75 lb

- Fasten base securely to ceiling structure using appropriate fastening hardware (not provided).
- CAUTION: Be sure your structure and mounting hardware can handle the weight.
- Use wire rope or chain to allow hanging sign to self-balance.
- Do NOT allow bare wire rope or chain to rub on eyebolt or wire ring.
- Wire rope or chain should be protected to prevent fraying or failure.
- Hang level.
- Not rated for outdoor use.

#### Maintenance:

No regular maintenance is required for this unit.

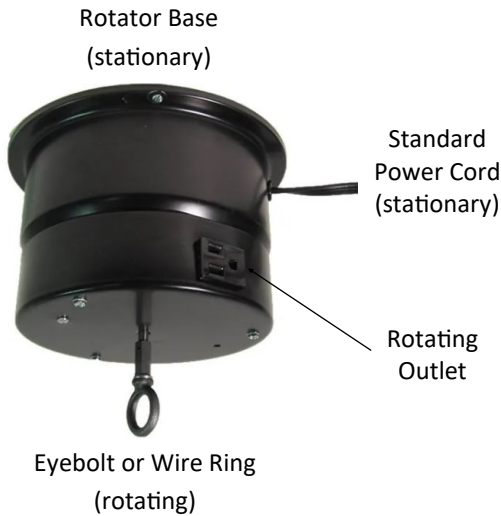

<b>⚠ WARNING</b>	
	Disconnect power before servicing or installing. Do not touch any electrical components while unit is connected to power source.
	Keep hands clear while operating. Read installation and maintenance instructions prior to operation.

#### Unit with rotating wires/outlet:



- **WARNING!** Electrical components are live when unit is plugged in.
- Do NOT exceed rated electrical capacity of unit (8A).
- Plug display wiring into Rotating Outlet on turntable.
- Plug Power Cord into wall outlet.

#### Limited Warranty:
